USE OF SOFTWARE DESIGNATED AS SUBJECT TO THE SYBASE OPEN WATCOM PUBLIC LICENSE SOFTWARE DESCRIBED BELOW—("SOFTWARE") IS SUBJECT TO THE TERMS AND CONDITIONS OF THE LICENSE AGREEMENT SET FORTH BELOW IN THE SYBASE OPEN WATCOM PUBLIC LICESNE SET FORTH BELOW—("LICENSE"). YOU MAY NOT USE THE SOFTWARE IN ANY MANNER UNLESS YOU ACCEPT THE TERMS AND CONDITIONS OF THE LICENSE. YOU INDICATE YOUR ACCEPTANCE BY IN ANY MANNER USING (INCLUDING WITHOUT LIMITATION BY REPRODUCING, MODIFYING OR DISTRIBUTING) THE SOFTWARE. IF YOU DO NOT ACCEPT ALL OF THE TERMS AND CONDITIONS OF THE LICENSE, DO NOT USE THE SOFTWARE IN ANY MANNER.

- 1. <u>ApplicationGeneral</u>; Definitions. <u>This License applies to any Original Code (defined below) so designated by the original licensor and any Modifications (defined below). This License applies only to the following software programs: the open source versions of Sybase's Watcom C/C++ and Fortran compiler products ("Software"), which are modified versions of, with significant changes from, the last versions made commercially available by Sybase. As used in this License:</u>
- 1.1 "Applicable Patent Rights" mean: (a) in the case where the Original LicensorSybase is the grantor of rights, (i) claims of patents that are now or hereafter acquired, owned by or assigned to the Original LicensorSybase and (ii) that cover subject matter contained in the Original Code, but only to the extent necessary to use, reproduce and/or distribute the Original Code without infringement; and (b) in the case where You are the grantor of rights, (i) claims of patents that are now or hereafter acquired, owned by or assigned to You and (ii) that cover subject matter in Your Modifications, taken alone or in combination with Original Code.
- 1.2 "Contributor" means any person or entity that creates or contributes to the creation of Modifications.
- 1.3 "Covered Code" means the Original Code, Modifications, the combination of Original Code and any Modifications, and/or any respective portions thereof.
- 1.4 "Deploy" means to use, sublicense or distribute Covered Code other than for Your internal research and development (R&D) and/or Personal Use, and includes without limitation, any and all internal use or distribution of Covered Code within Your business or organization except for R&D use and/or Personal Use, as well as direct or indirect sublicensing or distribution of Covered Code by You to any third party in any form or manner. 1.4 "Externally Deploy" means: (a) to sublicense, distribute or otherwise make Covered Code available, directly or indirectly, to anyone other than You; and/or (b) to use Covered Code, alone or as part of a Larger Work, in any way to provide a service,

including but not limited to delivery of content, through electronic communication with a client other than You.

- 1.5 "Larger Work" means a work which combines Covered Code or portions thereof with code not governed by the terms of this License.
- 1.6 "Modifications" mean any addition to, deletion from, and/or change to, the substance and/or structure of the Original Code, any previous Modifications, the combination of Original Code and any previous Modifications, and/or any respective portions thereof. When code is released as a series of files, a Modification is: (a) any addition to or deletion from the contents of a file containing Covered Code; and/or (b) any new file or other representation of computer program statements that contains any part of Covered Code.
- 1.7 "Original Code" means (a) the Source Code of a program or other work as originally made available by the Original LicensorSybase under this License, including the Source Code of any updates or upgrades to such programs or works made available by the Original LicensorSybase under this License, and that has been expressly identified by the Original LicensorSybase as such in the header file(s) of such work; and (b) the object code compiled from such Source Code and originally made available by the Original LicensorSybase under this License.
- 1.8 "Original Licensor" is the person or entity that owns the rights in the Original Code.
- 1.8"Personal Use" means use of Covered Code by an individual solely for his or her personal, private and non commercial purposes. An individual's use of Covered Code in his or her capacity as an officer, employee, member, independent contractor or agent of a corporation, business or organization (commercial or non commercial) does not qualify as Personal Use.
- 1.9 "Source Code" means the human readable form of a program or other work that is suitable for making modifications to it, including all modules it contains, plus any associated interface definition files, scripts used to control compilation and installation of an executable (object code).
- 1.10 "You" or "Your" means an individual or a legal entity exercising rights under this License. For legal entities, "You" or "Your" includes any entity which controls, is controlled by, or is under common control with, You, where "control" means (a) the power, direct or indirect, to cause the direction or management of such entity, whether by contract or otherwise, or (b) ownership of fifty percent (50%) or more of the outstanding shares or beneficial ownership of such entity.
- 2. Permitted Uses; Conditions & <u>Restrictions. Subject</u>Restrictions. Subject to the terms and conditions of this License, <u>the Original Licensor Sybase</u> hereby grants You, effective on the date You accept this License and download the Original Code, a world-wide,

royalty-free, non-exclusive license, to the extent of the Original Licensor Sybase's Applicable Patent Rights and copyrights covering the Original Code, to do the following:

- 2.1 <u>Unmodified Code.</u> You may use, reproduce, display, perform, <del>modify and distribute</del> Original Code, with or without Modifications, solely for Your internal research and development and/or Personal Use, internally distribute within Your organization, and Externally Deploy verbatim, unmodified copies of the Original Code, for commercial or non-commercial purposes, provided that in each instance:
- (a) You must retain and reproduce in all copies of Original Code the copyright and other proprietary notices and disclaimers of <u>the Original LicensorSybase</u> as they appear in the Original Code, and keep intact all notices in the Original Code that refer to this License; and
- (b) You must retain and reproduce a copy of this License with every copy of Source Code of Covered Code and documentation You distribute or Externally Deploy, and You may not offer or impose any terms on such Source Code that alter or restrict this License or the recipients' rights hereunder, except as permitted under Section 6; and-

- 2.2 <u>Modified Code</u>. You may <u>modify Covered Code and</u> use, reproduce, display, perform, <u>modify and internally distribute within Your organization, and Externally Deploy <u>Your Modifications and Covered Code</u>, <u>for commercial or non-commercial purposes</u>, provided that in each <u>instance:instance You also meet all of these conditions:</u></u>

- 2.4 Larger Works. You may create a Larger Work by combining Covered Code with other code not governed by the terms of this License and distribute the Larger Work as a single product. For example, if a third party patent license is required to allow You to distribute the Covered Code, it is Your responsibility to acquire that license before distributing the Covered Code.
- 3. Your Grants. In consideration of, and as a condition to, the licenses granted to You under this License, You hereby grant to Sybase and all third parties any person or entity receiving or distributing Covered Code under this License a non-exclusive, royalty-free, perpetual, irrevocable license, under Your Applicable Patent Rights and other intellectual property rights (other than patent) owned or controlled by You, to use, reproduce, display, perform, modify, sublicense, distribute and Externally Deploy Your Modifications of the same scope and extent as the Original Licensor Sybase's licenses under Sections 2.1 and 2.2, 2.3 and 2.4 above.
- 4. Commercial Distribution. While this License is designed to facilitate the commercial use of the Covered Code, the Contributor who includes the Covered Code or any portion thereof in a commercial product offering should do so in a manner which does not create potential liability for other Contributors. No one other than the Original LicensorSybase has the right to modify the terms applicable to Covered Code created under this License.
- 8. NO WARRANTY OR SUPPORT. The Covered Code may contain in whole or in part pre-release, untested, or not fully tested works. The Covered Code may contain errors that could cause failures or loss of data, and may be incomplete or contain inaccuracies. You expressly acknowledge and agree that use of the Covered Code, or any portion thereof, is at Your sole and entire risk. THE COVERED CODE IS PROVIDED "AS IS" AND WITHOUT WARRANTY, UPGRADES OR SUPPORT OF ANY KIND AND THE ORIGINAL LICENSORSYBASE AND THE ORIGINAL LICENSORSYBASE'S LICENSOR(S) (COLLECTIVELY REFERRED TO AS "THE ORIGINAL LICENSORSYBASE" FOR THE PURPOSES OF SECTIONS 8 AND 9) AND ALL CONTRIBUTORS EXPRESSLY DISCLAIM ALL WARRANTIES AND/OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES AND/OR CONDITIONS OF MERCHANTABILITY, OF SATISFACTORY QUALITY, OF FITNESS FOR A PARTICULAR PURPOSE, OF ACCURACY, OF QUIET ENJOYMENT, AND NONINFRINGEMENT OF THIRD PARTY RIGHTS. THE ORIGINAL LICENSORSYBASE AND EACH CONTRIBUTOR DOES NOT WARRANT AGAINST INTERFERENCE WITH YOUR ENJOYMENT OF THE COVERED CODE, THAT THE FUNCTIONS CONTAINED IN THE COVERED CODE WILL MEET YOUR REQUIREMENTS, THAT THE OPERATION OF THE COVERED CODE WILL BE UNINTERRUPTED OR ERROR-FREE, OR THAT DEFECTS IN THE COVERED CODE WILL BE CORRECTED.
